PROVIDING FOR APPROPRIATION AND EXPENDITURES TO OWNER(S) OF IMPROVED RESIDENTIAL, COMMERCIAL, INDUSTRIAL, INSTITUTIONAL AND EDUCATIONAL PROPERTIES TO ENCOURAGE AND PROMOTE OPTIMUM USE, DEVELOPMENT AND IMPROVEMENT OF LAND AND ECONOMIC GROWTH IN THE BOROUGH OF TULLYTOWN; DIRECTING PAYMENTS TO SUCH OWNERS(S); STATING AUTHORITY FOR ADOPTION OF ORDINANCES AND FINDINGS SETTING FORTH THE SEVERABILITY CLAUSE; STATING EFFECTIVE DATE OF ORDINANCE.

The content of the proposed Ordinance is summarized as follows: The Borough Council of the Borough of Tullytown, Bucks County, Pennsylvania (the Borough) has found and determined that appropriation of any payments from available funds of the Borough to the owner(s) of improved residential, commercial, industrial, institutional and educational real property in the Borough will encourage and promote optimum use, development and improvement of land and economic growth in the Borough by, among other things, furthering goals and objectives set forth in the Statement of Community Goals and Objectives adopted at the time of enactment of the Tullytown Borough Zoning Ordinance of 1974, as amended (The Zoning Ordinance), including attaining those gualities that will further enhance the Borough's value as a place to live and reside in, promoting civic pride and general maintenance of land parcels and neighborhoods, making a wide range of goods and services available to residents of the Borough by providing for a variety of commercial uses in the Borough and supporting the Borough's industrial base by encouraging local industrial activity and expansion in the interest of providing employment for residents of the Borough and generating tax revenues for the Borough and that appropriation and expenditure is consistent with the purposes of the Pennsylvania Municipalities Planning Code, the Zoning Ordinance and the Tullytown Borough Subdivision and Land Development Regulations of 1979, as amended (The Development Ordinance) and in the public interest.
