PUBLIC HEARING - ADOPTION OF 2019 TAX LEVY ORDINANCE--CONSIDERATION

Tax rate for general purposes – 7.5 mills Tax rate for street lighting purposes – 2 mills Tax rate for fire protection purposes – 2 mills

Mr. Walsh advised this ordinance and the budget have been available for public inspection at the Borough Hall since November 16, 2018 and a proof of publication showing this was advertised in the Bucks county Courier Times on November 16, 2018 indicated such.

Mrs. Conner advised that since Diane Beri has been appointed as a regular member, there is a vacancy on the alternate member position and added that Philip Antolino is interested in being appointed as alternate member to the Zoning Hearing Board, which term will expire December 31, 2019.

Mrs. Johnson made a motion to appoint Philip Antolino as alternate member of the Zoning Hearing Board for the unexpired term of December 31, 2019, by adopting Resolution #404. Mr. Pirolli seconded the motion.
