October 19, 2021

President Nina Chrzanowski called the meeting of the Tullytown Borough Council to order with the Pledge of Allegiance on Tuesday, October 19, 2021 at 7:00 P.M.

GENERAL BUSINESS

Non-Uniformed Employees CBA—Consideration/Resolution

Miss Slemmer advised that she and some other Council members met and were involved in negotiations over the past few months. They have tentative Agreements to present to Council for their consideration.

Miss Slemmer made a motion to approve Resolution #468 and the Non-Uniformed Employees Collective Bargaining Agreement, seconded by Mr. Pirolli.

Police Collective Bargaining Agreement—Consideration/Resolution

Miss Slemmer made a motion to approve Resolution #469 and the Police Collective Bargaining Agreement, seconded by Mr. Pirolli.

Purchase of Police Body Cams—Consideration

Chief Doyle requested use of the money from the sale of the former police vehicles to purchase 8 body cams. The police department has special details from time to time, such as the St. Mike's fair when 6 additional police officers are on duty. He would like to have body cams for all of those officers when they are out doing the special assignments. The estimated cost is \$8720.00 from Watchguard Motorola Solutions.

Mrs. Kettler stated that we got the money back with the sale of just one of the vehicles. Chief Doyle explained that after the last meeting alone, we received \$11,100 for the sale of the vehicles. So far this year, we brought in \$22,600.

Mr. Pirolli made a motion to approve the purchase of eight (8) police body cams, seconded by Miss Slemmer.

Mrs. Chrzanowski stated that this is for the safety of both our officers and our residents. Miss Slemmer stated that it also saves a lot of money with the frivolous lawsuits.

Authorize Advertisement of Police Pension Ordinance—Consideration

Mr. Pirolli stated that the attorneys will handle the publishing of the information in connection with the Ordinance which changes the language from the old variation of the Pension to the new variance. Chief Doyle explained that it changes the age requirement from 55 years of age and 25 years of service to 50 years of age and 25 years of service. Council was provided with an Act 205 Actuarial Study which is the actuarial valuation. Mrs. Kettler asked if we know what this change would save. Chief Doyle advised once you have retired officers, you will save on the higher salaries, the longevity pay, and the vacation, personal and sick time.

Mr. Pirolli made a motion to authorize advertising of Ordinance #403 Police Pension Ordinance, seconded by Miss Slemmer.
