TULLYTOWN BOROUGH COUNCIL MEETING September 27, 2023

President Mary Ann Gahagan called the meeting of the Tullytown Borough Council to order on Wednesday, September 27, 2023, at 7:00 p.m. followed by the Pledge of Allegiance.

PUBLIC COMMENT

Kelli Donlen 10 Lakeside Drive, she just wanted to share this. She has a person in her house who has cognizant decline and unable to get out of the house by himself. I reached out to the police department, and they referred me to Chief Martin. They were able to set up an emergency alert. If we call 911 and someone was dispatched to my house, they know that my loved one needs help - cognitively and for ambulation. It is a service that she was unaware of, and she wanted to make the public aware of it. Mrs. Donlen also mentioned that she noticed that a lot of things are missing on the Agenda. She asked if there was a reason why these things were missing. All the reports are gone. Ms. Gahagan responded that is a catch-up meeting from the beginning of the month. She advised that they were going to put the Relay for Life on the Agenda. Mrs. Donlen advised that she noticed that the hiring of the part time police officers is gone and all the Borough reports are gone. Ms. Gahagan explained that we will do it next month. Mrs. Chrzanowski asked why it isn't being done this month. She asked the solicitor if it needed to be done every month. Mr. Sacco responded that the President decides what is on the agenda. Ms. Gahagan responded that they are trying to get this over with and pay the bills.

Mr. Pirolli stated that they need officers and asked why the two part time police officers were taken off agenda. Mr. Servis stated that the Chief's report stated that the are graduating from the Police Academy on the 13th of October. Ms. Gahagan

stated that they will hire them at the next meeting. Mrs. Chrzanowski asked what happens if they get another job. People are being hired from the Academy all the time. Mr. Sacco advised that the part time police officers could be hired before they graduate the Academy but would not be able to start until after graduation.

Mrs. Chrzanowski made a motion to amend the agenda to hire 2 part time officers, seconded by Mr. Pirolli. Mrs. Chrzanowski commented that she did not understand why this meeting was different. It seems strange to her. Ms. Gahagan stated that it was not strange to her.

Mr. Pirolli made a motion to amend the agenda to hire a full-time officer, seconded by Mrs. Chrzanowski. Mr. Pirolli commented that the full-time officer left over a month ago and he wants to start the process to hire a full-time officer to replace the one that left.

The majority of Council was against the motion, the motion did not carry.

Matthew Goulet stated that he was speaking on behalf of his father, Bruce Goulet. Mr. Goulet provided all of Council with a copy of his speech. His son read his letter. My name is Bruce Goulet and a resident of Tullytown Borough for 37 years. He listed all of the committees he served on. He built a shed and has a permit that has expired. He must now apply for a new permit. He has always had trailers on his property and uses these trailers to store miscellaneous supplies. Recently he replaced the 2 trailers with one large trailer, and he spoke with Tullytown Zoning Officer, Sally Bellaspica. She indicated that since the trailers have remained on the property since the 1980's, the trailer should be grandfathered and no permit should

be required. His property is zoned for light industrial. His father feels that the code enforcement officer is attacking him. He is being fined for weeds that are not even on his property. It has become a nuisance for someone who has served this community for so long. He is retired and wants to enjoy the life he has spent building in this community. Russ Sacco advised he believes that Mr. Goulet is asking for a waiver and his son confirmed that they are asking for a waiver of the permit for the trailers that he already had grandfathered in the past and a waiver of the permit for the shed. Mr. Sacco advised that the issue did go before District Justice Hughes, who heard the case and ruled in favor of the Borough. He can gather from Beau Fleming a quick summary of the case and provide it to Council at the next meeting.

Debra Henry, 52 Lilac Lane, asked if under Borough Ordinance Boroughs are required to discuss certain things at every meeting. Mr. Sacco advised that Council is required to have a meeting once a month and required to have on the Agenda things that have to be voted on such as paying bills, land development, zoning hearing board intervention. Ms. Gahagan stated that they did do that. Ms. Henry asked how many police officers are on staff right now. Mrs. Chrzanowski stated that there are 7 part time, 4 full time. Ms. Henry asked how many more do we need? Mrs. Chrzanowski replied that she would have to ask the Chief. Ms. Henry stated that she was wondering why the chief was sitting in the back. Ms. Gahagan responded that Council had his report. Ms. Henry asked why no one was answering her as to why the Chief was sitting in the back. Mr. Pirolli stated that is why he asked why the hiring of the part time police officers was taken off the agenda. Mrs. Chrzanowski responded that she and Matt are on Council, and they have no idea either. Ms. Gahagan responded that they supply them with a copy of their reports. Ms. Henry asked again why the Chief is sitting in the back. Ms. Gahagan explained that they did not meet in early September. They were just going to meet in October but there was so much argument about it. Ms. Henry said it seems like there is a lack of structure and transparency.

Mr. Pirolli said he is being asked about the chief being fired and he has no idea what is happening. He asked Ms. Henry if she heard the same thing. Ms. Henry stated that she has heard that, as well. Mr. Pirolli said people are asking him why he doesn't know since he is on Council and he states that we have never had a meeting about it. Mrs. Chrzanowski stated that people in other townships are hearing it. Mrs. Chrzanowski stated that the Chief's report states that they need more officers. Ms. Henry asked if he was still the Chief. Ms. Gahagan responded she thinks so. Mr. Saunders replied that he is the sitting chief. Ms. Henry asked why they won't hire part time police officers. Ms. Gahagan replied that they have not graduated yet and in two weeks they will be hired.

Ms. Henry stated that if someone sees something and someone else sees something, if two more people see something and say the same exact same thing.

Ms. Henry stated what are the odds that all 4 of those people are wrong. She stated that she had high hopes for the chief but since he is sitting in the back, he is on his way out.

Kelli Donlen, 10 Lakeside Drive, stated that we all need to work together. The disrespect that goes on is ridiculous. People need to respect the residents. You are elected officials and should have respect for all residents. Do what is best for all residents and not just for yourselves. Mrs. Donlen stated that Council asked everyone to wait until they hired a chief. She said the Chief is fabulous and does a great job and it is a shameful the way things are being done.

Jesse Walters, 188 Kenwood Drive South, wanted to say thanks for the signs in the park and thanks to Mr. Conallen and Mr. Fitzpatrick for securing the grant. Anything for Tullytown is a good thing and it is appreciated.

You and a care giver can come and stay for free and everything is provided for you if you live too far away for your cancer treatments. It has been a wonderful event here and has saved us thousands of dollars and it has been fabulous to work here and we appreciate it.
