a) Resolution #511—Min. Mun. Obligation (MMO) Police Pension Plan 2025—Consideration

Mr. Sacco explained that the increase in the minimum municipal obligation for the police pension and non-uniform pension was due to the actuarial valuation done as of 1/1/23, which showed a significant market decline that occurred in 2022. The Police Plan showed a -14.7% return in investments and the Non-Uniform Plan return in investments was -13.2%. In addition, the Police Plan included a change in the normal retirement age from 55 to 50.

Mr. Sacco said it needs to be in the form of an agreement if the Borough agrees to maintain the cemetery.

If the Borough desires to move forward, we can follow up with a blight ordinance. Mr. Pirolli mentioned that he is against it because of the eminent domain provision. Several residents have expressed concern.

Mr. Torpey asked for permission to file an application to Liquid Fuels to use the funds to pay for the balance of the road program. The Borough has received a bill for \$250,000 for most of the work but there is still due approximately \$50,000. Council agreed.

CHIEF'S REPORT

Mr. Saunders mentioned that trucks are speeding down Main Street. He doesn't see any police officers on this side of town. These are things we need to address. The dump trucks are flying past this building and asked if the police are doing patrols on Main Street. Acting Chief Aldsworth mentioned that he tried to make a change to the schedule, and he was shut down by the Mayor. Acting Chief Aldsworth said the answer he got from the Mayor did not make any sense. He wanted to move the new hire to day shift, Monday to Friday. Everyone has different strengths, and he believes this person's strength is traffic enforcement. He had a game plan to get more enforcement on Main Street. It was requested that the Mayor bring a report to the next meeting with a plan to control truck traffic on Main Street.
