d) Levittown Trail Right of Way—Consideration

In order for the project to proceed, each municipality must grant a Right of Way. The County is paying for the trail which will run through the 3 municipalities. The Borough will be responsible for signage and maintaining the trail

Mr. Pearl questioned the location of the Right of Way. It was explained that the piece of property is across from the Dunkin Donuts on the Levittown Parkway side.
